

## **Privacy Policy**

This privacy statement is made on behalf of Super Forex Financial Pty Ltd (ABN 42 125 839 572; AFSL 443886). All references to “Superforex”, “we”, “us” or “our” in this policy are references to Super Forex Financial Pty Ltd.

### **Superforex Respects Each Individual’s Right to Privacy.**

We know how important it is for us to safeguard any personal information that may reveal your identity or account information, whether you are our client or a visitor to our Web site’s public domain.

### **Your Privacy is Our Priority**

Superforex is committed to its privacy obligations under the National Privacy Principles contained in the Privacy Act 1988. This privacy policy describes how we handle and protect personal information we collect about individuals who apply for or receive our products and services.

### **How We Collect Personal Information**

When you apply for or maintain an account with Superforex, we collect personal information about you for business purposes, such as evaluating your application to open account, processing your requests and transactions, informing you about products and services that may be of interest to you, and providing client service. The personal information we collect about you may include:

- Information you provide to us on applications and other forms, such as your name, address, date of birth, occupation, employer, assets and income, telephone or mobile number, email address, tax file number, nominated Bank account details;
- Information about your transactions with us and with our affiliates;
- Information you provide to us to verify your identity, such as a passport, or received from other entities not affiliated with Superforex.

### **How We Protect Personal Information**

We take all reasonable steps to protect your personal information from misuse, loss, unauthorised access, modification or disclosure. We limit access to your personal information to those employees who need to know in order to conduct our business, service your account and providing you with a broad range of products and services. Our employees are required to maintain and protect the confidentiality of your personal information and must follow established procedures to do so. We maintain physical, electronic and procedural safeguards to protect your personal information. We do not disclose your name or personal information to anyone unless authorised, or required by law, to do so.

### **About Cookies**

Cookies are small files containing information that a Web site uses to track its visitors. Superforex may set and access Superforex cookies on your computer, enabling us to learn which advertisements and promotions bring users to our Web site. Superforex or any of its affiliates or divisions may use such cookies.

### **About Hyperlinks**

Superforex’s Web sites may contain hyperlinks or “links” to other sites, and other sites may “link” to our sites. These Web sites that may be linking to or from Superforex’s sites may have their

own privacy policies. Superforex's privacy policy applies exclusively to Superforex and information collected by us. Superforex is not responsible for the privacy policies or the content of the sites you link to, nor do we have control over the use or security of information provided by you or collected by those sites. If you choose to link to one of these Web sites, you may be asked to supply registration or other information. It is important that you realise this information is going to a third-party, and you should become familiar with the privacy policy provided by that third-party.

### **Superforex Security Technology**

Superforex uses Secure Socket Layer (SSL) encryption technology when transmitting information, including any payment information. This technology is designed to protect you from having your information intercepted by anyone other than Superforex while it is being transmitted to us.

We also use other safeguards such as firewalls, authentication systems (e.g., passwords and personal identification numbers) and access control mechanisms to control unauthorised access to systems and data. However, you acknowledge and accept that any services provided through the Website involve transmissions over the internet and that such transmissions are therefore subject to the internet's inherent risks. Whilst we acknowledge our responsibility to take reasonable security precautions, you also acknowledge and accept that, as with any network, you may also be exposed to unauthorised programs transmitted by third parties, electronic trespassing and/or the failure of information and data to reach their intended destinations and/or erroneous receipt or misdirection of such information. Although our and our suppliers' privacy and security features are designed to reduce these risks, we cannot guarantee that the risk can be eliminated completely. You therefore acknowledge that we will not be liable for any breach of confidence or unauthorised access and use arising as a result of such event.

### **Disclosure to Non-Affiliated Third Parties and Regulatory Bodies**

In order to support the financial products and services we provide to you, we may share the personal information described above with third-party service providers and joint marketers not affiliated with us, including:

- Financial service institutions (advisors, dealers, brokers, trust companies and banks) with whom we have joint marketing agreements, such as agreements to market financial services or products that we jointly offer, endorse or sponsor; and
- Companies under contract to perform services for us or on our behalf, such as service providers that prepare and mail statements and transaction confirmations or provide data processing, computer software maintenance and development, transaction processing and marketing services.
- These companies acting on our behalf are required to keep your personal information confidential.

We may also be required to provide your personal information to the Australian Securities & Investments Commission, Australian Taxation Office, AUSTRAC, law enforcement agencies and other regulatory and government bodies from time to time in Australia. We may collect, use and disclose personal data about you, including personal data you may voluntarily disclose to us in any manner, so that we can (i) carry out our obligations with respect to the services that we provide; (ii) carry out our everyday business activities and dealings with you; (iii) compile statistical analysis of the pages of the Website visited; (iv) monitor and analyse

our business; (v) participate in crime prevention, legal and regulatory compliance, including screening and comparing such data against sanctions and other databases used for crime prevention purposes; (vi) market and develop other products and services; (vii) transfer any of our rights or obligations in relation to the services that we offer; and (viii) process your personal data for other related purposes. If you do not provide us with your personal information, or if you provide us with inaccurate or incomplete information, we may not be able to provide you with our services, including giving you access to our Websites.
